ANNEXURE - 2

GENERAL CONDITIONS OF SALE/DISPOSAL

1. Inspection of the materials :

All scrap materials will be sold on either weight basis (in MT) or on basis as specified in Table 'A' [Part- 1] on "**As Is Where Is, Arising Basis and No Complaint**" basis. The materials will be available for inspection at the respective site on production of this catalogue to warehouse scrap yard Staff, Mumbai Refinery Staff on duty on any working day and time specified in this catalogue till **01.12.2022** up to 15:00 HRS with prior appointment.

COVID – 19 CLAUSES :

- Only one individual from 2 scrap buyer firms per day shall be allowed for inspection. The timings shall be 10 am – 12 noon for one individual per firm and 1pm -3 pm for second individual per firm.
- **Inspection period shall be of 02 (Two) working days so as to cover max of 16 parties.**
- **In case additional request received, parties are requested to pool their resources and appoint common surveyor for inspection of lots.**
- Apart from above, additional Covid – 19 protection clauses shall be conveyed as Corrigendum in due course.
- Trucks and loaders have to be cleaned and thoroughly sanitized before entering the premises of the Refinery.
- All personnel of the buyer who comes into the premises of the refinery will be screened for a rise in temperature above 37 degrees Centigrade. Those having temperature above 37 degrees C will not be allowed to enter.
- All the personnel of the buyer should always wear a new 3 ply surgical mask, which is changed every day. In addition, they should follow all the guidelines as prescribed by the Ministry of Health and Family welfare pertaining to the prevention of COVID 19 virus spread like social distancing from others, frequent hand washing , not spitting in the premises etc. etc.
- Only one person should be allowed to interact with the concerned BPCL official. Others should not wander around the area and should be near the truck and loaders.
- They should not leave/dump anything in the refinery premises, that they have brought from outside.

2. Earnest Money Deposit (EMD):

- a. For participating at our e-Auction, the intending bidders shall pay refundable Earnest Money Deposit (EMD) by NEFT/RTGS as mentioned against each Category mentioned in Table–A [Part–1] on or before **01.12.2022 and 02.12.2022** before 16:00 HRS. No interest is payable for the deposit amount held by us.
- b. The EMD payments of unsuccessful bidders shall be paid through RTGS/NEFT payment without any interest subsequently within a reasonable time to their bank account provided by them. No interest will be payable for such refunds. In case of any undue delay in refund through RTGS/ NEFT due to unforeseen reasons at BPCL vendor due to any issue related to bank account or any other delays, BPCL is not liable for any claims of interest or any disputes arising on this account.

- c. The successful party will be advised the outcome of the e-auction result by issuing a letter of allotment within a reasonable time, i.e. 2 weeks approximate after the e-auction after getting internal approvals. The successful party's EMD will be refunded only on completion of the job to the full satisfaction of the Corporation & submission of No claim certificate. No claim certificate is to be submitted personally to scrap yard on last date of upliftment so that sale order closure & EMD refund activity can be processed on priority.
3. Participation in e-auction will mean that the party has inspected the facilities / materials / lots / nos. available for sale / disposal at site as per auction details in Table-A [Part-1] on as is where is and no complaint basis and is fully satisfied / understood the lot details and site conditions familiarizing himself regarding the condition, size, quantity, quality, weight, numbers etc. of the items available for sale / disposal.
4. No claim shall be entertained in case of any variations in quantities particularly on down ward side or condition / quality / weight / numbers of the materials etc. at the time of upliftment which may kindly be noted.
5. There can be only one H-1 bidder per lot / item at any given time. If more than one bidder bid, same value for an item / lot, the bidder who quotes the highest price first as per the server time is considered as the H-1 bidder for that lot / item.

8..Auction Result:

- a. Auction Result will be declared subject to confirmation from BPCL. The result will be declared within 2 weeks approximate from the date of Auction.
- b. The rate offered by the bidder shall be considered as Basic Price per Unit of the items mentioned or per lot price as mentioned in the e auction. All taxes, Duties, GST, TCS or any other statutory levies or taxes as applicable under the relevant GST act / IT Act or any other act shall be charged extra at the rate prevailing at the time of sale letter/delivery/invoicing. At the time of receipt of payment towards sale of scraps items as mentioned in the tender documents, GST @ 18% will be charged along with 1% TCS. Same shall be adjusted at the time of final invoicing; accordingly differential amount if any shall be refunded / recovered from the bidders. No interest claims shall be entertained by BPCL on account of advance receipt from the bidders.
- c. The present tentative rate of GST is given In Table "A" [Part -2]. However, these Taxes, as applicable shall be on actuals. Tax Collection at Source [TCS] @1% of [basic value + GST] will be charged extra to all Bidders for all items. Successful bidder has to deposit the amount of equal to [basic + GST + TCS]. BPCL would provide Tax Collection Certificate to successful Bidder. In case, TCS is not applicable bidder can take refund from appropriate authority based on TCS Certificate of BPCL.
- d. Please note that taxes/duties, TCS etc. statutory levies shall be as applicable at the time Of sale letter/upliftment/invoicing. Decision in regard to applicability of GST/TCS rates etc. as decided by BPCL would be final and binding to the successful bidder and bidders cannot claim/dispute on this matter.
- e. Any failure to accept the rate of taxes/duties/TCS etc. as may be indicated by BPCL in the sale letter/ at the time of upliftment/ in the invoice, BPCL reserves the right to forfeit EMD and cancel sale letter without assigning any reasons.
- f. - f. For material's sold on and "LOT" basis , the above clauses "13-c" & "13-d" shall not be applicable.

14. Removal of Materials:

- a. The Buyer will employ his own labour and means; at his own cost and risk for removal/collection/shifting of scrap, segregation (in case it is required) as per schedule.
- b. The payment of wages/compensation to the laborers will be the sole responsibility of the buyer. The buyer shall ensure that his workmen do not loiter around within the stores area of the factory. They shall not touch any material except those materials shown to them and he will be solely responsible for ensuring that material being loaded is as per his sale order. They shall not be involved in any malpractice/misconduct in BPCL premises. If any of his workmen is even found violating these restrictions as per BPCL rules & regulations as a buyer, the buyer shall be responsible for making good the loss to the owners on which their decision shall be final and binding.
- c. BPCL reserves the right to stop any material from being uplifted if it is disposed off/planned to be disposed off separately or is a part of other tender/sale order, BPCL decision will be final and binding.
- d. Irrespective of the condition of the deteriorated scrap material, choice of size, thickness, condition shall not be criteria for upliftment, Buyer will have to uplift the same as directed by BPCL.
- e. For ongoing sale orders, buyer allotted the sale order in the present tender will be allowed to uplift the balance material after the upliftment of material under existing sale orders (i.e. on First in First out basis) . Buyer will have to load as per priority as decided by BPCL w.r.t. the area/items/location, as per BPCL instruction buyer will plan loading accordingly.

- f. Each truck shall be weighed, both before and after loading on weighbridge and weighment shall be witnessed jointly by officers of BPCL, buyer/ buyers representatives & CISF. Buyer shall note that during the weighment of tare weight and gross weight on weighbridge, buyer supervisor/owner responsible for uplifting activities shall note down the weight displayed outside the weigh bridge cabin and ensure that net weight is correctly printed on the invoice issued by BPCL. Any discrepancy observed after truck is left the scrap yard, the responsibility of discrepancy shall lie with buyer and buyer shall be answerable for any queries/justification required by BPCL. Such discrepancy shall be considered as misconduct on the part of buyer and BPCL can take suitable action as deemed fit against such buyer.
- g. The buyer shall complete the transaction including collecting the scrap material before 4.00 p.m. on any working day with prior appointment with the concerned department within the stipulated delivery days. The items offered for sale will be handed over to the successful tenderer by BPCL official at site on production of our Authority Letter which will be issued after the payment of total sale price including Taxes & TCS etc.
- h. The Seller reserves the right to unload the vehicles for inspection purpose. If it is suspected at any time that the buyer has loaded the material /materials for which he is not buyer or if the buyer is found to carry excess material than that mentioned in the documents, the company will be within its right to detain the truck, unload the goods at the cost & expenses of the buyer & terminate the contract forthwith and forfeit the EMD, sale value & claim such further losses and damages that may be caused to the Seller.
- i. Any damage to the BPCL (Seller's) or Third Party's properties within Seller's premises during removal of the items will have to be made good by the successful buyer at their own cost. The Seller reserves their right to claim from the buyer any expenses which might have been incurred by it over and above the EMD by way of restoring damages caused to properties belonging to the Seller/Third Parties by the action of such buyer or their men. Until such losses are reimbursed, delivery of the materials old will not be given to the buyer.
- j. Loading/Unloading will be carried out by the buyer at his own costs & risk. All material handling machines/equipment's, tools and tackles, labor, etc. or any other items as may be required to be supplied by party or as insisted by the seller for successful completion of the job will be arranged by the buyers at their own cost. Non-availability of the same will not be considered as a ground for 'Late-Lifting' of the materials.
- k. Scrap material shall be weighed with in BPCL premises in presence of the buyer and seller (BPCL representative) & CISF personal before clearance for dispatch.
- l. For material sold on "call-off & arising basis", BPCL will issue call-off as & when required. However in case BPCL does not issue call off within three months of last upliftment date of previous call off, the sale order shall be treated as closed & EMD Refund shall be processed in such case. The execution period of the sale order shall be maximum of one year duration.

15. Decision in case of disputes:

- a. In case of any dispute regarding the contract, the decision of the Seller shall be final and binding. If there is any dispute as to the last or highest bid or dispute in identifying the item belonging to particular lot, the dispute shall be determined by the Seller and their decision shall be final and binding to all.

16. Right of Acceptance/Rejection of offer:

- a. The Seller reserves the right to withdraw wholly or partially any or all the items set for sale at any time during the period of contract without assigning any reasons.

18. Termination of Contract: The Seller reserves the right to terminate the contract at any time by giving three days' notice on the following ground.

- a. Unsatisfactory execution or performance of the contract by the buyer.
- b. For improper behave or of the buyer or breach of the terms and conditions of the contract.
- c. Decision of the Seller to terminate the contract shall be final and binding and no claim for damages and compensation shall be entertained. In the event of the buyer or his agent or servant committing or attempting to commit theft, fraud, dishonesty or gross misbehavior in connection with the subject matter of this contract or in any other connection whatsoever concerning the business of the Seller, the Seller will be entitled to terminate the contract forthwith and forfeit the EMD/Sale Value at its sole discretion.
- d. In case of any incomplete job, or only part job done before the schedule time for completion, and if the delays are found to be attributable to the buyer's failures, the seller, i.e. BPCL if not satisfied with their performance, reserves the right to terminate the contract and award the job to any other Contractor at their cost and risk.

19. Passing of Property In the goods:

It is expressly made clear that the property in the goods whether sold by units, weights or lots, whether arranged or otherwise, will remain that of the Seller and will pass on to the buyer only when material is taken out by the Buyer from the factory Premises after getting valid dispatch documents.

20. Safety And General Regulation :

- a. All Safety Regulations as applicable in Mumbai Refinery of BPCL, shall be followed by the buyer and their employees in removing the items. The buyer should obtain suitable Work Permits/Safety Certificates for excavation, hot work etc. from the authorities at site in case it is required. The work in such cases will be allowed to carry out during working hours of the Refinery/ CRDC/MMBPL locations etc. The work should be commenced only after obtaining necessary permission from the Corporation's representative.
- b. The workers employed to carry out the work should observe the Corporation's rules and regulations at the respective places. Successful buyer shall provide necessary personal protective equipment (PPE) to all its workman deployed for scrap loading.
- c. Basic /minimum PPE such as safety shoes, helmet, hand gloves & overcoat/ apron, goggle are must. Cost towards this shall be borne by buyer. Apart from this, in case any additional safety equipment suggested by BPCL safety department in the interest of job/ safety of workman, shall be provided by buyer for safe loading. Utmost care to be taken to avoid any incident/ accident. Job shall be carried out safely.
- d. Any injuries to workers employed by the successful buyer while removal / transport of the items and any risk / liabilities (including under Workmen's Compensation Act etc.) arising out of the same, will be the liability of the buyer and not of the Corporation. The Buyer should also indemnify the Corporation against all liabilities / demurrage claims arising out of non- compliance by the buyer of all statutory requirements currently in force or made applicable subsequently. The successful buyer will keep the Corporation indemnified against all damages/ claims arising of the aforesaid.
- e. All notices, letters sent to the buyer shall be deemed to have been received by him/them within 48 hours from the time of posting if the same are sent at the address given by the buyer. 2. Enter "Login ID "and" Password".
3. When a bidder logs in for the first time for the particular auction, bidder has to accept to the Terms & Conditions. (After accepting to the terms & conditions of the company only you can be able to bid)
4. After accepting to the terms you will be taken to the auction-listing page where you will be able to see all the details about the auctions.
5. Click on Auction Room link on the top of this page. This will take you to the Bidding Page. A separate Window opens which is the Bid room.
6. Now Start Bidding. You can either Bid Manually OR can use Auto-Bid .(In Auto bid, the computer will bid on your behalf up to that value you given).
7. In the Manual Bid option, you can put your bid in the text box available for each item and submit it every time. A bid confirmation pop up box will appear to confirming whether you want to go ahead with the bid posted or not. If you confirm the bid, your bid will be posted If your bid is accepted, that will be displayed in "My Last Accepted Rate" column on your right side screen. Also the highest bid amount will be displayed in "H1 Rate" column.
